With reference to your memo on the captioned subject, it is to inform on scrutiny of the diversion proposal submitted vide your memo under reference the CA land on GIS-based DSS it is seen that out of 30ha demarcated, 26 ha under moderate dense forest, 1 ha non-forest and 3 ha open forest. Further the CA Scheme submitted by the Divisional Forest Officer, Parlakhemundi in which he has proposed to take up 1000 seedlings per ha. Besides that the following discrepancies are noticed below pertaining to the above forest diversion proposal. KML file of CA land with Topo Map has not furnished by you

- 1. Due to revision of wage rate, the Compensatory Afforestation Schemes is required to be revised at the current wage rate of Rs.280/- per manday as well as approved cost norm of PCCF(O).
- 2. Map submitted at plate No.VI has not been clearly depicted the boundary of CA area.
- 3. DSS submitted in soft copy is not having the gap to take up plantation. Revised site with proper map, DSS, suitability certificate working circle in which belong has to be furnished for taking up technical approval of the competent authority.

Hence, you are requested to take necessary action in the matter at the earliest and comply the above observations.
