उपर्युक्त प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित त्रुटियाँ पाई गयी। राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

- 1- The locations of the villages to be benefited by the proposed road are not marked on the KML file. Accordingly, the State Govt. is requested to mark the locations of concern villages in the KML file of diversion area uploaded in online portal.
- 2- The muck disposal plan is not prepared in proper like calculation of muck generated, swelling factor etc. Further, there is no forest or non forest land is proposed for dumping the muck seems in appropriate. Therefore, the State Govt. is requested to submit the detailed muck disposal plan addressing all these factors.
- 3- The distance of the target village from the existing road is also required to be submitted by the state govt.
- 4- The road is passing through the area proposed for CA which may reduce the effective area proposed for plantation. The concerned DFO will visit the area and provide comment in this regard.
- 5- As per the DSS analysis of the CA area proposed for plantation is having 1.0 ha area of MDF out of total 5.40 ha. Therefore, the State Govt. is requested to provide report/clarification as mentioned in point 5 above.

- 6- The CA area proposed for plantation is having 1.0 ha area of MDF out of total 5.40 ha. This fact may also take in consideration while providing report/clarification as mentioned in point 5 above.
- 7- NPV is calculated at older rates. State Govt. is requested to submit/ upload NPV calculation sheet as per the new rates.
- 8- It seems that the road is proposed only to connect two villages which are individually situated on existing road which does not seem to be justified. State Govt. is requested to justify the same.
