Subject: Diversion of 2.4281 hectares (revised from 2.428 hectare) of forest land in Kadugodi Plantation Village Sy.No.1 " Bidarahalli- I Hobli, Bengaluru East Taluk" Bengaluru Urban District (and Urban Forest Division) for construction of Ground Level Reservoir (GLR) under Cauvery Water Supply Scheme (CWSS) stage-V, along Eastern Route CP-12, in favour of the Executive Engineer" Bangalore Water Supply and Sewerage Board (BWSSB), Kapila Bhavan. 4th Block, Jayanagara. Bengaluru-reg.

Sir,

I am directed to refer to State Government letter No.FEE244FLL2023 (e) dated 09/10/2023 on the subject mentioned above. In this regard, it is requested to provide the information/ clarification on the following for further processing of the proposal:-

- As per the alternatives examined, user agency has requested BMRCL to provide the unused land in their possession for construction of proposed GLR. In this regard, it may be noted that the Regional Office, Bengaluru vide its letter dated 18th December. 2019 had accorded approval for diversion of 18.11 ha of forest land in Sy. No. 1 of Kadugodi Plantation in favour of BMRCL limited for construction Bengaluru Metro Project, Phase-2. The State Government may explore the possibility of re-diversion of unutilized portion of forest land, if any, under the possession of BMRCL limited for this project.
- It may be clarified whether the degraded forest land identified in Sy. No.1 of Hulikunte SF, Bengaluru Rural Division is in addition to the non forest land identified towards land to land purpose or otherwise.
