Sub.: Diversion of 433.2273 ha Protected Forest land for four lanning with paved shoulder NH configuration "Dwarka-Khambhaliya-Devariya" (Km 130+00 to Km 203+530) and "Dhrol-Amran-Maliya" (Km. 00+000 to Km 13+600 & Km. 24+000 to Km 72+000) road of Jamnagar, Devbhumi Dwarka & Morbi district in favour of Project Director, NHAI, PIU, Rajkot.

Sir,

With reference to the above mentioned subject and letter under reference, I am directed to request you to submit the following information /documents/clarification:

- 1. The Survey of India toposheet map of CA land of Jamnagar and Devbhumi Dwarka shall be submitted and same shall be uploaded on web portal.
- 2. Cost-benefit analysis in prescribed format shall be submitted.
- 3. FRA certificate shall be uploaded on web portal.
- 4. CRZ clearance for this proposal shall be submitted.
- 5. Environment clearance for this proposal shall be submitted.
- 6. CWLW comments for this proposal shall be submitted.
- 7. The DSS analysis shows that KML file of proposed diversion for Jamnagar division and Rajkot division falls in 03 patches and 01 patch of reserved forest area respectively (copy enclosed). This may be clarified.
- 8. The DSS analysis of KML file of proposed CA shows that some patches of CA area is having agriculture encroachment and one patch (Jodiya) of proposed CA is almost full of water (copy enclosed). Hence the State Govt. may submit revised CA free from all incumbencies.

Further, necessary action will be initiated only after receipt of information.
