Sub: Proposal for diversion of 10.30 ha forest land for construction of Foot Track from Tappa to Goying (0.00 km to 18.60 km) by Border Road Organization in Kurung Kumey District of Arunachal Pradesh.

Ref: (i) Letter No. FOR.3-235/CONS/2021/2810-14 dated 27.07.2022 of Govt. of Arunachal Pradesh.

Sir.

Please refer the State Govt letter on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. I am directed to inform that the proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980 and rules/guidelines framed thereunder and following lacking information/documents has been observed:-

- 1. The SoI map indicating the proposed foot track mentioned on "Bara CAMP" and the State Govt is also to clarify whether the "camp area" is involved in this proposal or not.
- 2. The status of mutation and notification certificate of the identified CA area.
- 3. The SoI map indicating 3-alternate route examination with justification for selecting this proposed area.
- 4. The calculated revised rate of NPV amount of the forest land being diverted in respect of this instant proposal as per the Ministry letter File No. 5-3/2011-FC(Vol-I) dated 21.03.2022, if not submitted.
- 5. The aerial distance of the proposed area from the nearest Protected Area/Wildlife Sanctuary/National Park.
- 6. The corrected kml file of the proposed area in polygon feature as it is submitted in linear feature.
- 7. The identified CA area comprises of 2.088 ha very dense forest and 8.352 ha moderately forest as per DSS. State Govt is therefore to conduct site inspection of the identified CA area by an officer not below the rank of Conservator of Forest and report to be submitted mentioning vegetation and forest cover density with photographs of the inspecting officer taken at the site,, or else, an alternate CA site is to be submitted along SOI maps, site suitability certificate, GPS-coordinates, shape file etc.

State Govt. is requested to kindly furnish the above requisite information to this office for further processing of this proposal.
