- 3. Details of check list mentioning page number of DP.
- 4. Statement showing the details of forest area involved i.e., Survey No./ Coupe No./ Compartment No., etc., & item wise beak up of the forest area proposed for diversion in the prescribed format (Checklist No. 7).
- 5. Statement showing the details of non-forest area involved in the proposal in the prescribed format **(Checklist No. 8)**.
- Undertaking by the user agency to pay the Net Present Value (NPV) of the forest land in the prescribed format (Checklist No. 13).

- 7. Undertaking by the user agency to pay the additional Net Present Value (NPV), if any of the forest land proposed for diversion in the prescribed format.
- 8. Certificate for minimum use of forest land to be submitted by user agency in the prescribed format (Checklist No. 11).
- Undertaking by the user agency to bear the cost of compensatory afforestation in the prescribed format (Checklist No. 12).
- 10. A certificate from the competent authority in the state in the prescribed format that all forest rights under the Forest Rights Act, 2006 have been settled in respect of the forest area proposed for diversion in the prescribed format **(Checklist No. 14)**.

In view of the above, the diversion proposal in Six sets (6) is returned herewith for necessary compliance at your end.
