of forest land in Social Forestry plantation area in Othivakkam for erection of 230 kv DC line on MC tower by making LILO of existing Ottiyambakkam to Omega feeder 2 at the proposed Mambakkam 230/110 kv Substation in Chengalpattu District, shortcomings noticed on the proposal had been informed to the Conservator of Forests vide Principal Chief Conservator of Forests references 6th cited above for rectification

A copy of the DO letter received from the Principal Secretary/ Chairman & Managing Director/ TANGEDCO & TNEB Ltd and Chairman TANTRANSO, Chennai has been sent vide Principal Chief Conservator of Forests reference 8th cited above for necessary follow up action.

In the reference 9th cited the proposal has been resubmitted through online and hard copy of documents have been furnished.

In the hard copy of the documents furnished, Compensatory Afforestation scheme in 8.54 ha to an financial outlay of Rs. 1,68,95,173/- has been furnished However, in the Part-II of Form-A, compensatory afforestation scheme in 11.38 ha of degraded forest area with financial out lay of Rs. 2,46,57,121/- has been uploaded.

The Conservator of Forests has been repeatedly requested to scrutinize the proposal received from the District Forest Officer with reference to the documents uploaded in the web portal. However proper scrutiny has not been done and this lead to delay in processing the proposal at all levels.

Hence, the Conservator of Forests is requested to resubmit the proposal with the above rectification urgently.


