1) while scrunishing the Part-II & III of Form-A furnished by the District Forest Officer and Chief Conservator of Forests, as reported by the Chief Conservator of Forests, revised kml file of the compensatory afforestation land along with DGPS reading and Survey of India topo sheet indicating the boundary of CA land have been uploaded.

But, revised CA scheme and site suitability certificate have not been uploaded and already uploaded CA scheme details have been deleted.

Hence the Chief Conservator of Forests is informed to rectify the following. (i) to upload the revised CA scheme and site suitability certificate in the CA scheme section in Part-II of Form-A by the District Forest Officer.
