

With reference to the above cited subject, the Range Forest Officer, Kaggalipura Range and the Asst. Conservator of Forests, Bangalore South Sub-Division had inspected the spot and submitted a report vide ref(3).

After verifying the report, it was noticed that the proposed pipeline passes through the forest and 140 Euclayptus trees has to be cut. Hence, you are hereby informed to submit a revised map

marking the pipeline in the adjacent road in order to prevent the felling of large number of trees and the revised map has to be uploaded in Parivesh Portal.
