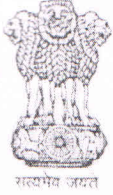

Therefore, it is requested to furnish the same at the earliest.

Further, the State Government was requested to furnish complete compliance report in respect of the forest area diverted earlier to an extent of 2259 ha for Seabird project. However, the Compliance report submitted by the user agency in this regard is provided by the State Government. Therefore, it is requested to kindly provide the conditions wise compliance report duly verified by the State Forest Department.
