With reference to the above cited subject, the Principal Chief Conservator of Forests, (FC) Bengaluru in his letter (2) cited above and followed by the directions issued by the Government of Karnataka in its letter (1) above, has called for certain additional information of 9.547 ha. of forest land in favour of M/s. Vedant Limited for the establishment of conveyor project for iron ore mine bearing ML No. 2677 duly examining the issue as per rules along with your specific opinion/detailed report in this juncture.

While going through the report submitted by you in letter (4) cited above, it appears that, you have not inspected the said mining lease area in order to ascertain the status of mining and permitted quantity of iron ore and present status of mining and its transported quantity of iron ore.

Hence, you are therefore instructed to inspect the ML area in question and arrange to ascertain the additional information on the three points as raised by the Government of Karnataka as your physical verification is quite mandatory to give your specific opinion/ detailed report on all the above issue. In future you are also strictly instructed not to submit such in consistent report in order to avoid un-necessary correspondence and delay in this instant case.
