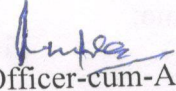
The proposal received vide your above referred communication is found incomplete. The following shortcomings have been noticed in the proposal which is to be completed. Proposal folders received are returned herewith. All the requisite documents may please be placed in the proposal folder with proper numbering and index.

1. Part-I as downloaded from the online webportal & placed in the proposal folder at P.No. 9-14, wherein componentwise breakup and other information does not tally with the online Part-I. As Part-I on prescribed format has already been placed in the proposal folder, therefore, it (Part-I as downloaded from online webportal) should be replaced from the proposal folder & numbering of each page should be done accordingly.
2. In justification for locating the project in forest land, it has been stated that alternative alignments have been explored but the details of alternative alignments alongwith number of trees and area coming in the alternative examined have not been given in the justification.
3. Alternative alignments have been marked in the KML file but in the digital map alternative alignments have not been marked. Digital map, showing alternative alignments alongwith dumping sites, if any, should be marked in the digital map. Digital map showing alternative alignments alongwith Geo-referenced co-ordinates may be uploaded against C(iv) of Part-I appropriate and be placed in the proposal folder accordingly.
4. The proposal involved felling of huge number of trees. 639 number of trees are proposed to be felled in the proposal. Possibility to reduce the number of trees should also be explored.

5. In the proposal folder only abstract of trees have been found placed at Page No. 39 but enumeration list duly counter signed by DFO concerned is not found attached.
6. Detail of length and width of the road has not been found attached in the proposal folder.
7. Recommendation of the DFO concerned as uploaded in Part-II against column No. 16 have not any date.

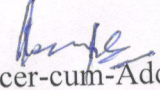
