With reference to the subject cited above, I am directed to inform that the proposal mentioned above has been discussed in the 17th REC held on 27.10.2022 at Integrated Regional Office, Shillong. As desired by the REC, State Govt. is requested to furnish the following to this office for further processing of this proposal.

1. To conduct a site inspection of the identified CA area by an officer not below the rank of Conservator of Forest and report to be submitted mentioning vegetation and forest cover density along with photographs of the officer taken on site, or else an alternate CA site is to be submitted along with SOI maps, site suitability certificate, GPS co – ordinates, shape files etc.
2. To clarify on the validity of the PML and submit the copy of the extension of petroleum mining leased.
3. The user agency to appoint an officer to co-ordinate with the project affected people and the name of the officer and his/her contact details is to be provided.
