Sub.: Diversion of 208.89 ha (188.97 ha in Indore Forest Division and 19.922 ha in Badwah Forest Division) Forest land for the gauge conversion of railway line between Mahu-Sanawad in Indore and Khargone districts in favour of Western Railway, Indore.

Ref.: Minutes of meeting of REC File No. 6-REC10/2014-BHO/Part-I/786 dated 10.10.2018. Sir.

With reference to the above mentioned subject and letter under reference, I am directed to say that the proposal was discussed in REC meeting held on 10.10.2018 and the REC examined the proposal for diversion of forest land under Forest (Conservation) Act, 1980. The REC also saw the proposal on the Decision Support System (DSS) of FSI. Accordingly, the REC approved the proposal for diversion of 208.89 ha (188.97 ha in Indore Forest Division and 19.922 ha in Badwah Forest Division) Forest land for the gauge conversion of railway line between Mahu-Sanawad in Indore and Khargone districts in favour of Western Railway, Indore, MP on usual standard terms and condition and following specific condition:-

- The FRA certificate in prescribed format from concerned District Collector shall be obtained and submitted to this office and uploaded on e.portal before issuance of working permission, as in case of linear project.
- 2. Details of displacement of the peoples involved in this project shall be submitted.

The Stage-I shall be issued only after receipt of following information:-

1. The proposed CA is in 08 (eight) patches totaling to 437.93 ha as per DSS analysis. The 155 ha is MDF out of total CA land. So, revised CA land (map and CA scheme) details in open forest with C.D. < 0.4 as per the latest FSI report shall be submitted and uploaded on e.portal.
