महोदय,

उपरोक्त विषय पर सन्दर्भित पत्र का आशय ग्रहण करते हुए प्रस्ताव पर ध्यानपूर्वक विचार करने के
उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी हैं। अतः
राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें। ताकि अग्रिम कार्यवाही सुनिश्चित
की जा सके:-

1. KML file of the proposed CA area has been found uploaded at para-C of online Part-I instead of the KML file of the proposed road. State Govt. may upload the correct KML file of proposed road at para-C of online Part-I for examine the proposal.
2. As per DSS analysis, KML file of 19ha. area found uploaded instead of 17.154 ha CA area. State Govt. may clarify the discrepancy and may submit/upload the correct information.
3. Digital map of proposed road submitted in photocopy. State Government may submit the original copy of digital map.
4. FRA certificates, SDLC proceedings and NPV calculation sheet found uploaded in photocopies. State Government may upload the original copy of FRA certificates, SDLC proceedings and NPV calculation sheet.
5. CA scheme uploaded online and submitted in hard copy are found different. Govt. may clarify the discrepancy and may submit/upload the correct information.
6. Cost benefit analysis submitted/uploaded in old format. Govt. may submit/upload the Cost benefit analysis in new format.
7. VLC proceedings of village Sansari, Basedi, Bansal and Musoli not found uploaded/submitted. State Govt. may upload/submit the VLC proceedings of village Sansari, Basedi, Bansal and Musoli in original.
8. Land schedule submitted/uploaded is found incomplete. State Govt. may submit/upload the complete land schedule.
9. The alignment of the proposed road and the alternate alignment shown in the copy of SoI toposheet indicating boundary of forest land proposed to be diverted uploaded at para-C(iii) is lacking in clarity.

10. The note containing justification for locating the project in forest land uploaded at para-D(i) of Part-I is not satisfactory and the copy of map indicating location of alternative examined uploaded at para-D(ii) is lacking in clarity.
11. It is seen from the muck disposal plan that the calculation of muck has been done for 10110 mtr length of the road passing through forest land only and the muck likely to be generated due to construction of road in nap/private land has not been taken into account for preparation of muck disposal plan. Further, it is seen from the dimensions of the 6 no. of muck disposal sites that the area of land comes to 1.78 ha instead of 1.48 ha shown in the muck disposal plan as well as component wise breakup in para-B-2.4 of Part-I. State Govt. may clarify the discrepancy and may submit/upload the correct information.
- ✓ 12. The CA estimates uploaded in online Part-I and Part-II and the CA site suitability certificate have not been signed by DFO. State Govt. may submit/ upload the documents duly C/s by DFO.
- ✓ 13. Although, 0.70 ha of reserve forest land is involved in the proposal but the working plan prescriptions have not given in para-5 of Part-II. State Govt. may upload the working plan prescriptions in para-5 of Part-II.
- ✓ 14. The geo-referenced digital map and the Sol toposheet map of the proposed CA area uploaded at para-13 of Part-II have not been authenticated by DFO. State Govt. may submit/ upload the documents duly C/s by DFO at para-13 of Part-II.
15. In the bar chart uploaded in online Part-I, the RoW has been mentioned as 7.00 mtr in RF, VP and Benap land and 9.00 mtr in nap land. But the RoW of 9.00 mtr is mentioned in RF, VP, Benap and nap land in another bar chart uploaded in online Part-II. State Govt. may submit/upload the correct information in this regard.
16. The NPV calculation sheet provided at page no -126 of the hard copy is different from the NPV calculation sheet provided at page no. 127 and the one uploaded in online Part-I. Govt. may clarify the discrepancy and may submit/upload the correct information.
17. State Government may remove the above shortcomings submit the hard copy of the above mentioned points.
