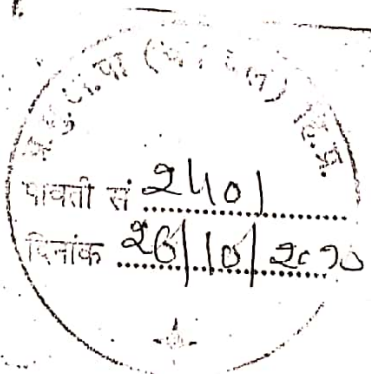

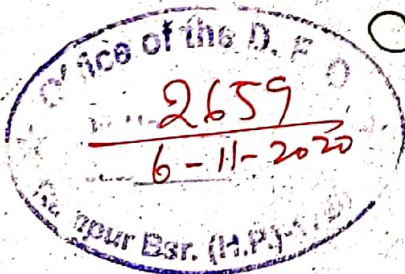

Sir,

I am directed to refer to the Government of Himachal Pradesh's letter No. **No.Ft.48- 1063/2005 (FCA) dated 18.09.2020** on the subject mentioned above for seeking prior approval of the Central Government under Section -2 of the Forest (Conservation) Act, 1980. After scrutiny of the proposal it is found that the following information/documents related to the proposal needs to be obtained from the Government of Himachal Pradesh:

- i. Revised KML file of the proposed forest land is not found on PARIVESH portal. It has been observed that the KML file currently uploaded on PARIVESH is same as the previously uploaded KML file. Therefore revised KML file of the proposed forest land being diverted be uploaded in polygon feature format.
- ii. Compliance report with respect to condition no 2 of the previous approval letter dealing with CA is incomplete. Govt, of Himachal Pradesh may furnish the comments in this regard.

In view of the above, the State Government of Himachal Pradesh requested to upload the information/Justification, as indicated above, on PARIVESH portal only, for further consideration of the proposal.
