Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **0.208 ha** of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

- 2. After careful examination of the above-mentioned proposal of the Govt of J&K, the following information/clarification is still required to be submitted:
- i) Layout plan uploaded in additional information (checklist) Part II at page no 4 is not legible, need to be upload clear layout plan.
- ii) True English translation of the ownership revenue record uploaded under SN 4 of additional Information details of part I.
- iii) The name of applicant, who is making application is Chetan Mahajan, whereas all other documents indicate Chetan Gupta. A clarification is needed, if the both names are of same person.
- iv) Since, the proposed site is Gair Mumkin Jhad and is forest for the purpose of FC Act, and non-linear, suitable equivalent CA site in the form of Non- Forest Land (NFL) has to be provided by the User Agency and the State Govt shall prepare CA scheme for the same NFL. The SOI toposheet, DGPS Map and land suitability certificate shall be modified based on the status of NFL.
- 3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
