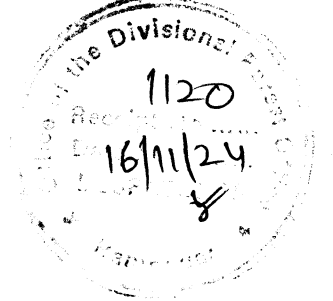

Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **0.85 ha** of forest land for non-forestry purpose in accordance with section 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980.

2. After careful examination of the above-mentioned proposal of the Govt of J&K, the following information/clarification is still required to be submitted:
 - i) As per CA scheme detail uploaded by concerned DFO under **para 13(2)** of online part-II, **1.80 ha** area is proposed for plantation of **1700 plants** among which only **1 ha** is available for plantation, which is not enough for the plantation of **1700 plants**, DFO needs to enhance CA area in order to achieve the targeted plantation.
 - ii) Muck disposal plan uploaded under additional information detail S.no 3 is not authenticated/ Countersigned by DFO.
 - ✓ iii) Geologist report is not uploaded by UA. User agency need to upload the same in online part-I.
 - ✓ iv) Undertaking for Muck Disposal/ Muck Restoration Plan is not uploaded by UA/DFO. User agency needs to upload Muck Disposal/ Muck Restoration Plan countersigned by DFO.
 - ✓ v) Biological & Engineering measures is uploaded under additional information detail S.no 22 of online part-II is unable to open. UA/DFO needs to upload the revise copy of Biological & Engineering measures.
 - ✓ vi) As per the uploaded KML. There exists a feature "Proposed Phase 2nd Road" which falls inside dense forest. UA needs to submit the detail justification for the same.


