During scrutiny of the said query compliance, following discrepancies has been observed in the said proposal:-

- 1) The Diverted area KML file has submitted is faulty.
- 2) Diverted area Kml file not submitted properly. As per area statement exact polygon not shown in the KML file and compartment boundary not highlighted on diverted area KML file. The revised KML file need to be submitted in 3 copies.
- 3) The forest area and non forest area and restored forest area should be shown in different colors.
- 4) Deputy Conservator of Forests, Alibag to re-examine diverted area KML file and C.A area KML file and revised KML file should be submitted in 3 copies.
- 5) Compartment boundary not shown C.A KML file.
- 6) If the restoration order issued by the concerned Collector office. the copy should to be submitted.

The above discrepancies should be complied at the earliest.
