In reference to your above mentioned letter where approval for above referred proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. The requirement of Non Forestland for proposal in AI (ix) of part I is mentioned as NIL which is incorrect.
2. The geo referenced map of the proposal has provided geo coordinates for few points. The required geo co ordinates to define curvilinear portion of the entry & exit has not been provided.
3. The estimation of crown density is less and needs revision.
4. The proposal is without submission of Site Inspection Report of the concerned DFO in GoI approved format.
5. The proposal is without site suitability certificate of compensatory afforestation from the concerned DFO.

Therefore, the original proposal is hereby returned for rectification/revision of the same as per the observations made above in point wise manner.


