
Please refer to the State Govt letter on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980, I am directed to inform that the proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980 and rules/guidelines framed thereunder and following lacking information/documents has been observed: -

1. The brief note on the existing road and its forest clearance status along with information of road prior and after this proposed road length.
2. The total length of the road involved both in forest and non forest land from Hamren to Howraghat with their chainage.
3. The existing Right of Way and proposed Right of Way.
4. Whether any muck disposal sites will be involved or not, if yes, the approved muck dumping plan with GPS co-ordinates, SoI map indicating the muck dumping site, area is to be submitted and if no, reason thereof.
5. The current status of the Forest Right Act, 2006 certificate of this proposed area.
6. The current status of the mutation and notification of the non forest land identified for CA site.
7. State Govt to comments on the proposed area as it is 'INVIOLATE' due to the presence of hydrological layer as per the DSS.
8. The comment of CWLW on the proposed area as the proposed area is a critical elephant habitat and reported of presence of wild animals like jungle cat, Barking deer, Hog deer, Jackal, Civet etc.

9. The HEC mitigation and conservation plan approved by CWLW.

State Govt. is requested to furnish the following to this office at the earliest for further processing of the proposal.


