In reference to the above mentioned Proposal received on the PARIVESH Portal at the level of the North Forest Division, it is stated that the joint inspection of the 5.25 Ha. of non-forest land proposed for Compensatory Afforestation in the above mentioned proposal, has been carried out by the undersigned on 11.01.2021, along with the Dy. Conservator of Forests, West Forest Division and officials of DMRC. During the inspection of the CA site, it has been brought to the notice by the officials of West Forest Division that the proposed Compensatory Afforestation land is a Protected Forest under West Forest Division, Department of Forest & Wildlife, GNCTD.

During the inspection of the CA site, it has been confirmed by the officials of West Forest Division that the said land proposed for CA is already a Protected Forest as per the affidavit of then Conservator of Forests, Sh. R. K. Goel, submitted in the Hon'ble Supreme Court of India in the matter of T.N. Godavarman Thirumulkpad Vs. Union of India & Ors. As per the annexure-II of the affidavit, there is approx. 12 Acres of Protected Forest in Dhulsiras Village, Dwarka, belonging to Forest Department, NCT of Delhi.

Therefore, you are requested to submit the revised/another Compensatory Afforestation land against the diversion of Forest land in the above mentioned FCA proposal. As the CA land needs to be revised therefore some other revised documents also needs to be submitted by the UA, which are as follows:

- 1. Details of revised non-forest land area identified for compensatory afforestation viz. Survey No./Compartment No./Khasra No./Khatoni No., village, Tehsil, District, etc., along with map in appropriate scale showing the boundaries of area needs to be
- 2. Revised Compensatory Afforestation Site Kml. file need to be submitted.
- 2. Revised Compensatory (including Khasra details) of the land Proposed for Compensatory Afforestation site (the map should be in appropriate scale and in proper format).

Therefore, now in order to process your proposal, you are requested to submit the details mentioned above at the earliest, so that the proposal will be processed on time.
