With reference to the subject and letter cited above, I am directed to inform that the information submitted by State Govt letter under reference above has been examined in this office and observed that State Govt has simply enclosed the reply whatever the user agency has submitted. State Govt is requested at least to cheek what is being sent by the user agency before forwarding it to this office to avoid unnecessary delay to such important infrastructure project meant for the development of the State. State Govt is therefore requested to submit the following to this office for further processing of this proposal:-

- 1. The justification on 3-alternate route examination mentioning ecological parameters i.e., forest area, density, forest type, habitat etc as the proposed length is mentioned as i.e., 42.767 km which is different in the submitted proposal i.e., 48 Km (approx).
- 2. The SoI map indicating the 3-alternate route examination mentioned at Sl No. 1 above.
- 3. The Right of Way of the proposed transmission line and not the RoW permission letter as submitted.
