

1. Reply of point 1, no correction is made in village wise breakup at para B 2.3 online Part I.  
**Action Required:-** State Govt. may review and correct this.
2. Reply of point 4 is still not correct.  
**Action Required:-** State Govt. may submit original hard copy of Justification for locating the project in forest area duly C/S by DFO and upload the same at Para D (i) online Part I.
3. In reply to point 2 & 7, CWLW simply informed that the aerial distance of diversion area is 7.4 km without any comments as the area falls in ESZ of PA.  
**Action Required:-** State Govt. may submit the comments of CWLW and upload the same at designated place.
4. Regarding point no. 5, administrative approval uploaded online is still not legible.  
**Action Required:-** State Govt. may submit clear copy of administrative approval and upload in additional document in Part I.
