9. Notification of the Karnala Bird Sanctuary to be submitted.
10. NoC copy from private land holders to pay compensate as per the prevalent rules, Act, and Guidelines to be submitted.
11. CA details not showing on Parivesh Portal Part-II.

The above discrepancies should be complied to this office at the earliest.
