Sir,

Please refer to the State Government's letter in the reference on the subject cited above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. State Govt is requested to kindly furnish the following information for further processing of this proposal:

- (i) The current status of mutation of the non forest land proposed for compensatory afforestation land.
- (ii) The original or colour scanned SoI toposheet indicating 15.20 ha of CA area as the submitted map is not legible.
- (iii) The GPS coordinates of the CA area as only one point coordinates has been submitted.
- (iv) The GPS coordinates of the proposed area.
- (v) The scientific names/ local names of trees mentioned in "Others" category in the submitted enumeration list.

- (vi) The letter certifying that 15 ha degraded forest afforestation is as prescribed by Working Plan, quoting para No.
- (vii) The Chief Secretary certificate on non-availability of non-forest land for the proposed compensatory afforestation in the prescribed format.
- (viii) Recommendation of the State Govt for this instant proposal.
- (ix) The density of forest cover of the proposed CA area is to be verified by conducting a site inspection by an officer not below the rank of Conservator of Forests as 27 ha has been observed as moderately dense forest as per the DSS.
