With reference to the subject and letter cited above, I am to inform that the information submitted by State Govt letter under reference (i) above has been examined in this office and following lacking information are observed:-

1. To submit the aerial distance of the proposed area from the nearest Protected Area/Wildlife Sanctuary/National Park and not from mid-coordinate of Daldali Reserved Forest and existing National Highway as submitted.
2. To clarify on the current status of the forest clearance of the existing road.

State Govt. is requested to kindly furnish the above requisite information to this office for further processing of this proposal.
