


Please refer to the State Government's letter in the reference on the subject cited above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal referred to above has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The following deficiencies have been observed in the proposal submitted by the State Govt:

- 1) Justification for proposing 33 ha of the CA site instead of double the degraded forest land.
- 2) It may be informed that the submitted compensatory afforestation site shows 23 ha (i.e 16 ha out of 24 ha and 7ha out of 9 ha) out of the total 33 ha proposed CA patches are found to be under Moderately Dense Forest as per the DSS.
- 3) The details of the alternative routes explored and reason for choosing the present alignment.
- 4) The original or colour scanned Sol toposheet indicating the alternate route examined along with the proposed route.
- 5) The compensatory afforestation scheme is to be technically approved and duly signed by the competent authority.
- 6) The detail of muck dumping area and quantity of muck to be generated.
- 7) The current status of Forest Right Act, 2006 certificate.
- 8) Large numbers of trees are listed in 'Others' categories is to be submitted with scientific names; if not, at least with local names.
- 9) The ROW width of proposed road.

- 10) The GPS coordinates of the starting and end point of each forest patches involved.
- 11) The GPS coordinates of the proposed road and CA site.
- 12) The total length of the proposed road
- 13) Scheme for raising avenue plantation on both side of the road technically approved by the competent authority.

State Govt is requested to kindly furnish the above information to this office at the earliest for further processing of this proposal.


