- Soft copy of DGPS map of forest area proposed for diversion, CA land identified **(ii)** are not appended to the DP.
- It is not mentioned whether EC/CTO for producing iron ore has been obtained by (iii) the lessee for this mining lease.
- Present status of compliance of order dt. 2.8.2017 in WP©No. 114/2014 by lessee (iv)and status of mining in the ML over the un-diverted/broken up sabik forest land has not been indicated.
