Immediate attention of the District Forest Officer, Kadapa is invited to the reference cited. In his reference 3rd cited, the report submitted by him in response to the Prl.Chief Conservator of Forests & HoFF, Andhra Pradesh, Guntur reference 1st cited is not fully convincible. As per the area statement submitted in reference 3rd cited, the average additional width (excluding existing width of 7.50mts) at left side of existing road from Km 51/000 to Km 58/500 is coming to 10.53 mts. The details are as follows.

Similarly at right side of the existing road the average additional width (excluding existing width of 7.50 mts) from Km 51.000 to Km 57.230 is coming to 12.69 mts. The details are as follows.

As said in District Forest Officer reference 3rd cited, the then Divisional Forest Officer, Proddatur (WL) in his report, it is mentioned that the existing road width is 7.00 mts and the proposed diversion area for upgradation of paved shoulders to a width of 5.00 mts on either sides over a length of 8.00 Kms. As such the area proposed for diversion may not exceeds 8.00 Ha. As such there is discrepancy in area statement. Therefore he is requested verify the measurements in the field physically and submit a detailed report after verifying the above additional average width as claimed by the user agency and also the existing road width to arrive the correct picture for submitting a area statement as desired by the Government within a couple of days without fail.
