Sir,

In inviting a reference to the subject and letter cited above, I am to inform you that the State Govt. has forwarded a proposal for diversion of 4.7685 ha of forest land for the purpose under reference above. The proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder where it is found that the proposal is in-complete. Hence, to ensure its completeness as per format and guidelines, the State Govt. is requested to furnish necessary information for further processing of the proposal as per the following:-

- (1) The soft copies of shape file (Geo-reference boundary) in respect of the proposed diversion site and proposed CA site may be furnished.
- (2) Muck Disposal Plan for the project duly approved / agreed by State Govt.
- (3) Form-II for non-linear project from the O/o District Collector towards the settlement of all claims and right over the proposed land under different rules / regulations / local laws and under Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 as required vide latest guideline of MoEF, New Delhi guideline No. 11-9/98-FC(pt) dated 05.07.2013 may be submitted by State Govt.
- (4) The State Govt is to clarify how the requirement of materials for construction of dam etc. can be met and its sources.
