विषय: Diversion of 33.71 ha. (5.69 ha. in Jind division. 17.79 ha. in Hisar Division & 10.23 ha. in Fatehabad Division of forest land for construction of channel for supply 180 Cs water to Nuclear Power Plant at Gorakhpur, Tehsil & District Fatehabd through old abandoned Sirsa Branch from RD 388500 to 424780 falling under Forest Division & District Hisar, Jind and Fatehabd, Haryana. संदर्भ: वन मण्डल अधिकारी, फतेहाबाद का पत्र क्रमांक 797 दिनांक 21.09.2022 (प्रति आपको भी सम्बोधित)

उपरोक्त संदर्भांकित पत्र द्वारा भेजी गई सूचना का अवलोकन करने उपरांत उसमें निम्नलिखित कमियां पाई गई हैं:-

1. SOI toposheet needs to be uploaded.
2. Fatehabad Forest Division:
 - (i) The KML of Chaharwala minor RD indicates plantation (CA Scheme) of 1400 plants in an area of 1.4 ha. However, an area much bigger (5ha.) approx. than required is indicated in the KML file which is unnecessary and can be reduced to 1.4 ha.
 - (ii) For plantation of 1900 plants, an area of 1.9 ha. should suffice, but an area of approx 3 ha. is given which needs to be rectified in KML for Kheri Dirty RD 44 to 58.
 - (iii) For plantation of 1000 No. of plants an area of 1 ha. is sufficient, however an area of 3.4 ha. approx is given for Deherman minor RD 26 to 30 in Tohana Range.
Similar is the case for rest of the CA sites it is suggested to mark boundary location for plantation of plants for case of monitoring, keeping in consideration the vegetative density of the area.
 - (iv) DGPS maps should be revised as per the modified KML file.
3. Hisar Forest Division.
 - (i) For plantation of 35580 No. of plants, an area of 35.58 ha. should suffice. However, collectively the KML files indicate an area of 84.2 ha. (22.95 ha. for Jaknal Hisar Railway line). This needs to be rectified accordingly for affective monitoring purpose.
 - (ii) DGPS map needs to be redone as per revised KML file.
 - (iii) SOI toposheet is correctly marked.
4. Jind Forest Division:
 - (i) A clear colored print of the SOI toposheet needs to be uploaded indicated the toposheet number.

- (ii) For plantation of 11380 No of plants, an area of 11.38 ha. should suffice, however a total area of 19.37 ha is given in the KML files which needs to be shortened. Moreover, the area under CA sites in the KML are densely vegetative area. It is suggested to come up with alternate CA sites.
- (iii) DGPS map needs to be redone accordingly.
