Please refer to your office Memo. 4705 dated 08.11.2021 on the subject cited above.

2 The proposal received vide your above referred communication is found incomplete. The following shortcomings have been noticed in the proposal which is to be completed. Proposal folders received are returned herewith. All the requisite documents may please be placed in the proposal folder with proper numbering and index as per complete checklist.

1. In online Part-I against column No. A (vii), estimated cost of the project has been mentioned as Rs. 400 lacs whereas against column No. 1. (iii) of the Part-I in proposal folder, estimated cost of the project has been given as Rs.4/- lacs.
2. Against column NO. K (i), whether the process for settlement of Rights under the Forest Rights Acts 2006 on the forest land proposed to be diverted has been completed? : No has been mentioned. FRA certificate has been obtained and placed in the proposal folder at P.No. 16 A) to 16 (E). 'Yes' is required to be mentioned against this column and FRA certificate as obtained should also be uploaded against this column.
3. Copy of approval of mining is not found uploaded against column No. M (2) iii of Part-I.
4. Copy of mining plan is not found uploaded against column No. M (2) iv of Part-I.
5. Against column No. M (2) vii, copy of map of the outer boundary of mining lease area is not found uploaded.
6. In online Part-I column No. M-5 (i), detail of bore holes has been filled. As this column is only for prospecting mining case, so detail against this column is not required to be filled up.
7. Against column No. M-5.2, of Part-I online, estimated reserve alongwith accuracy and confidence level has not been given.
8. Against column No. M-7 (i) proposed use of the minerals proposed to be raised from the mining lease: NIL has been mentioned. Proposed use of minerals proposed to be raised from mining lease area should be mentioned against this column.
9. Against column No. M -7 (ii) copy of details of the plan for the transportation of the minerals has not been found uploaded. The detail of the plan for the transportation as per mining plan is required to be uploaded against this column.
10. Online Proposal number be corrected in Part-II of the proposal folder.

11. Density of vegetation has not been mentioned against column No. vi of Part-II of the proposal folder.
12. Against column No. 5 of online Part-II, for working plan prescription for the forest land proposed for diversion, it has been stated that forest land falls under PWC and as for working plan prescription of Sh. Avtar Singh IFS. PWC stands for plantation working circle and protection working circle. It may clearly be mentioned against this column whether the land proposed for diversion falls in Plantation Working Circle or Protection Working Circle.
13. Against column No. 8 (iii) whether the forest land proposed for diversion is located within eco-sensitive zone(ESZ) of the Protected Area notified under Wildlife(Protection) Act,1972 (Note: In case, ESZ of a Protected Area is not notified, then, 10 kms distance from boundary of the Protected Area should be treated as ESZ): No has been stated. As per latest instructions received from GoI, if the proposed land is not located in the ESZ of the protected forest area, a distance certificate from DFO concerned is required to be placed in the proposal folder and upload the same in additional information detail in Part-II.
