Subject: Proposed Forest land diversion for four lane widening of Sikohabad-Bhogaon Road (SH 84) from chainage km 0.000 to chainage km 19.5185 requiring 26.143158 ha protected forest with felling of 2,414 number of trees and 4,452 plants & poles total 6, 866 number-reg.

Sir,

In reference to your above mentioned letter where approval for above referred forest land diversion proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. Area of proposed forest land as per kml file is 23.642 ha whereas proposal is for 26.143158 ha. This discrepancy needs rectification.
2. Geo coordinates of all key points forming the proposed forest land for diversion has not been provided and the same needs submission.
3. Cost Benefit analysis provided in part I G (i) is not as per revised guidelines.
4. Land schedule provided with the proposal does not provide details of balance width of RoW remaining after proposed diversion.
5. Extent of Compensatory Afforestation patches fall short by 0.3 ha as per GIS DSS, it would be pertinent to increase proposed CA area of one of the patch to meet requirement of DDFL.
6. (a) Kml file of 17.3 ha proposed compensatory afforestation patch is not accessible online.
(b) Kml file of 9.986316 ha compensatory afforestation patch shows existence of road in proposed area.
7. The proposal is along with additional Compensatory Afforestation (brick guard plantation) apart from compensatory afforestation on double degraded forest land which has not been specifically recommended by the State Government. The estimated cost of brick guard plantation is Rs 4.4 crore. The justification of the additional CA has not been provided by the concerned DFO.
8. The certificate from DM under FRA 2006 does not contain name of all villages having jurisdiction over concerned forest land and the certificate does not provide regarding rights of pre agricultural communities.
9. Correct part V has not been uploaded with the online proposal.
