Madam/Sir,

I am directed to refer to the Government of Odisha's letter No. 10F (Cons) 210/2015, 16637/F/E, Bhubaneswar, dated 19.09.2015, on the above mentioned subject for seeking prior approval of the Central Govt. under Section 2 (1) (ii) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. Further, it is informed that the proposal along with additional information submitted by the State Govt. vide letter dated vide letter no. 17522/9F (MG) - 12/2023 dated 20.08.2025 was considered by the Advisory Committee Meeting held on 26.09.2025. After the examination of the proposal, the Advisory committee has deferred the proposal; for want of the following document/ information:

- The State government shall consult with the NTCA, ICFRE, and WII to understand and address the concerns raised by the NTCA and those raised in the report of the sub-committee. It shall then submit a detailed report outlining mitigation measures to minimize the project's impact on wildlife along with recommendations and justifications.

In view of the above, the State Government is requested to submit the information/documents, as indicated above, to this Ministry for further consideration of the proposal.
