With reference to the subject and letter cited above, I am to inform that the minutes of the 65<sup>th</sup> Meeting of the Standing Committee of NBWL submitted vide State Govt letter dated 02.11.2021 has been examined. The above mentioned drilling proposal submitted by State Govt was from the year 2018 and proposals are still pending for Stage-I at present. The proposals appear to be on process from 2015-16 onwards and there may be possibilities of changes in the features and other settlement issues in the forest patch particularly with reference to CA. In order to have a complete information the Stat Govt is requested resubmit the site suitability certificate and non-encumbrance certificate in respect to the sites identified for CA for the above mentioned drilling proposals.

The information may be submitted at the earliest to enable this office for taking further necessary action from this end.
