Sub:- Proposal for diversion of 410.073 ha & Re-diversion (change of land use) of 171.774 ha of forest land in respect of Integrated Lakhanpur-Belpahar-Lilari OCP, 40 MTY of Lakhanpur Area, MCL-regarding submission of CA scheme

Ref: Memo No.1468 dt.16.07.2021 of RCCF Sambalpur Circle

In inviting a reference to your above cited memo on the captioned subject, this is to inform you that, on scrutiny of the CA Scheme enclosed in above mentioned proposal, the following shortcomings are noticed.

- 1. You have proposed to take up ANR plantation 600 seedlings per ha over 417.073 ha of non-forest Government land identified in village Sudanga under Banspal Tahasil for plantation, but on verification of KML and Shape file enclosed in the DP for the purpose of CA through DSS, it is found that 184 ha is MDF and 233.0 ha is Non-forest and open forest category. So, you are requested to re-visit the site to take up Block Plantation over 233.0 ha by planting 1600 seedlings per ha to accommodate 3,72,000 nos. of seedlings and balance 45,073 nos. of seedlings to be accommodate in MDF area over 184.0 ha. to fulfill the criteria of loss of "trees by trees".
- 2. The barbed wire fencing which may cause harm to the Wild Animals is to be replaced by the Chain Link Mesh fencing.
- 3. In the CA scheme, the pit size is to be changed to 45 cm X 45 cm X 45 cm as 18 months old seedlings will be planted.
- 4. The CA sheeme needs to be revised at the current wage rate of Rs.311/- per manday. The revised CA scheme may be submitted through your RCCF at an early date.
