
Kindly received your online proposal on dated 11.01.2021 and hard copy of proposal on dated 11.12.2020 on the subject cited above.

2. From the perusal of proposal folders and online web portal of the proposal following shortcomings have been noticed:-

1. In the online portal point No. A-1(vii) of Part-I project cost Rs. 200 Lac has been mentioned but, in the hard copy of Part-I 1(iii) Rs. 1895.81 Lac has been mentioned but same is not readable also, the project cost is required to be matched with each other i.e hard copy and online portal. Please correct the same.
2. The Part-I of the proposal has been placed in the proposal folder but name below the signing authority has not been mentioned in the hard of part-I, which required to be mentioned.
3. In the online portal of Part-I C(ii) (a), the KML file has been found uploaded but village to be benefited and alternative alignments have not been mentioned, which required to be mentioned in KML file and require to be upload revised KML file in online portal.
4. The liner plan of diversion of forest land has been placed in the proposal folder and found uploaded in the online portal also but component wise proper dimension of the area has not been mentioned, which require to be mentioned in liner plan. Please placed/ upload revised liner plan.
5. In the online portal E (iii) of part -I employment generation 40000 mandays has been mentioned but in hard copy at page No. 17 325754 person mandays has been mentioned. The employment generation could be matched with each other i.e. hard copy and online portal also.
6. In online portal K(i)(a) report of settlements of rights under RFA, 2006 has been uploaded and also placed in the proposal folder, but Annexure-V issued by Gram Sabha/ FRA committee and their meeting proceedings have not uploaded in online portal and not placed in the proposal folder also. Please upload the same in online portal and placed in the proposal folder also.
7. Some documents uploaded in online portal at Sr. No. 4 & 7 in additional document but same are not matched with hard copy placed in the proposal folder, please delete it and upload correct copy.

Therefore, you are requested to kindly attend the above mentioned shortcomings and submit the same to this office immediately. However, four numbers of proposal folder received vide letter JSD-EE-TNG-WA-FCA/2020-11-11632-34 dated 09.12.2020 are returned herewith for favour of information and further necessary action.
