The Chief Conservator of Forests (T), Thane vide letter dated 21/12/2022 has submitted proposal diversion of 9.9249 ha. forest land for rehabilitation & up-gradation of existing highway to 2 lane/ 4 lane with Paved shoulder under configuration from Pen-Khopoli (Km.00 + 000 to Km 33+328) section of NH-166 D (Pen Khopoli) on Engineering Procurement & Construction (EPC) Basics in Raigad District in the State of Maharashtra. Following discrepancies has been observed in the said proposal:-

1. Diverted area KML file not submitted along with proposal.
2. Forest and non-forest area showing polygon in KML to be submitted.
3. CA Area KML file not submitted along with proposal
4. Copy of the 7/12 extract of proposed C.A land not enclosed along with proposal.
5. Copies of the 7/12 extract of proposed diverted area Gut No.30,44Pt.21 not enclosed along with proposal.
6. Ferfar copy of the private forest gut nos. to be submitted in 3 copies
7. Private forest regarding documents i.e. restoration order and other relevant documents to be submitted.
8. NoC copy of the private forest holders to compensate the compensation as per prevailing Rules, Act and guidelines.
9. There is 316 tree felling involved in the project. The said trees felling girth wise abstract to be submitted duly signed by the Deputy Conservator of Forests, Alibag Forest Division, Alibag
9. Original notification of Reserved forest land showing proposed Gut No. to be submitted.
