2.	It is mentioned in Compensatory Afforestation details that the total amount of Compensatory Afforestation to be collected from the User Agency is Rs.16.54136 Lakhs. By verifying the breakup details; it is found that this amount is total sum including the Net Present Value, Nursery and Plantation of 0.84 Ha of Compensatory Afforestation area along with the maintenance cost of plantation of 1st year to 10th year. Since the amount to be collected for Net Present value should be dealt separately and should not be included in Compensatory Afforestation. The Compensatory afforestation amount may alone be furnished in this section.	The said rectifications are made in the annexure I and attached herewith.
