**Subject: Diversion of 1.27 ha. of forest land in Nellore, Venkatagiri, Udayagiri, Kavali and Atmakur ranges of Nellore Division for laying Optical Fiber Cable along the road within the existing Right of Way (RoW) in favor of M/s. Reliance JIO Infocomm Ltd., Visakhapatnam for providing 4G communication in the State of Andhra Pradesh-reg.**

Sir,

I am directed to refer to the State Government's letter No. 623/Section-II/2020/1113681 dated 24/10/2024 on the above subject. In this regard, it is informed that during the Site Inspection of the proposed area by this office, it was noted that a trench was dug in Puduru RF where M/s Vindhya Tele Links Ltd. had laid the duct and OFC whereas M/s. Reliance Jio Infocom Ltd had laid the duct but not OFC and the violation occurred in the same alignment and in the same trench.

This office vide letter No. F.No.4-APB200/2023-VIJ/524 dated 10/12/2024 had authorized the State Government for filing complaint for violation of the provisions of Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980 against all the authorities/persons responsible for the said violation before the competent court, within a period of 45 days from the receipt of the said communication.

It is, therefore, requested that the action taken by the State Government in the matter may kindly be intimated to this office so that the proposal can be further processed.
