- 1. An extent of 6.53 ha. of non-forest land for raising Compensatory Afforestation (CA) has been identified in Hariharapura village, Shivamogga District and it is reported that said land is dry deciduous forest. It may be clarified whether the proposed CA land attracts the provisions of Forest (Conservation) Act, 1980. If so, the same is required to be proposed in double the extent of area proposed for diversion as per para no. 2.4 (i) of Chapter of 2 of Hand book of guidelines issued under Forest (Conservation) Act, 1980.
- As per the site inspection report of DCF concerned, it is reported that forest area proposed for diversion has been encroached. However, it is not reported that whether the encroachers have any claim on forest land as per Forest Rights Act,
