Sub:- Regarding submission of proposal for diversion of forest land for non forestry use under forest (Conservation) Act-1980 for the work "Rehabilitation & Up-gradation of NH-149 from Km. 0/00 to 68/280 (Pallahara to Pitiri Section) to two lane with paved shoulders under NDHP- IVA in the State of Odisha on EPC basis". (Pallahara bye-pass) **Proposal No. FP/OR/Road/17128/ 2015 dt. 21.12.2015 – State S. No. OR/087/2015 dt. 21.12.2015**

With reference to your above cited letter, you are requested to please comply the following deficiency/ short comings of your proposal immediately for further scrutiny and onward transmission of the diversion proposal to the Regional Chief Conservator of Forests, Rourkela Circle, Rourkela.

- 1- Administrative approval (details of the approvals obtained/ sought for under the Act in respect of the project) with cost of the project.
- 2- **Part-I of Form A** in the prescribed format of hard copy is wanting.
- 3- Forest and Non-Forest area not marked in Topo Sheet.
- 4- A detail of Land Schedule of the forest area duly signed by the Tahasildar Pallahara is wanting.
- 5- A detail of Land Schedule of the non forest area duly signed by the Tahasildar Pallahara is wanting.
- 6- Detailed map showing the impacted forest and non forest area in Revenue village sheet (16"=1 Mile) duly signed by the Tahasildar Pallahara is wanting.
- 7- Tree enumeration list of non forest area along with abstract is wanting.
- 8- Abstract of Tree enumeration list of forest land wanting.
- 9- FRA certificate of Collector, Angul is wanting.
- 10- Area to be change to 4.546 ha. instead of 4.564 ha. in the undertaking furnished in the D.P. for payment of Compensatory afforestation (P-17)

- 11- Certificate as regards the fact that in case approval under the Act for diversion of the forest land is declined, it is technically feasible to execute the project along an alternate alignment without involving diversion of forest land.
- 12- Undertaking as regards execution of work on non-forest land shall not be cited a reason for grant of approval under the Act and in case approval under the Act for diversion of forest land is declined, width of the portion of road falling in the forest land will be maintained at its existing level.
- 13- The identified non- forest land for compensatory afforestation should be properly demarcated with 4' height RCC pillars as per extant guideline.
- 14- GPS coordinates of all posted pillar along with pillar number and distance between pillars should be inscribed in the RCC Pillar.
- 15- Pending Court Matters, if any, as regards the proposed diversion proposal.
- 16- Cost Benefit ratio.
- 17- Environmental clearance certificate.


