Attention of the District Forest Officer is invited to the references cited above. For raising Compensatory Afforestation, the District Forest Officer has followed the model estimate communicated in Principal Chief Conservator of Forests Ref.No.TS4/22483/2022 Dated.13-10-2022.

In the estimate for CA submitted by the District Forest Officer it is seen that the Compensatory Afforestation has been proposed for planting 3000 Nos seedlings over an extent of 5.00 Ha in the identified non-forest land in SF.No.692/4 of Kammampatty village at the cost of Rs.73,21,390/- and remaining 2000 Nos seedlings proposed for planting over an extent of 2.50 Ha in the degraded forest area of Barigam-B Reserved Forests at the cost of Rs.28,40,545/-. Thus the total amount of Compensatory Afforestation estimate has been furnished for Rs.1,01,61,931/-

However on scrutiny in this office few defects have been noticed as detailed below.

Planting


1. Sl.No.14 providing Brushwood fencing around each plant for Compensatory Afforestation plantation at non-forest land which is not approved in the model estimate. It requires to be provided with chain-link fencing (vide separate estimate) for 1000M length of periphery. The brushwood fencing provided in lieu of Chain-link fencing may be deleted.

Therefore the abstract estimate may be revised and furnished along with the CA estimate. Therefore the CA estimate received from the District Forest Officer is returned for rectification and resubmission immediately along with corrected signed hard copy of form A part II in respect of CA amount duly uploaded in the designated web portal
