I am directed to invite your attention to your reference 4th cited, wherein you
have sent a proposal for diversion of 0.053 ha of forest land for pathway to a length of
145m to agricultural land in Sy.No. 386 and 389 of K.C.Patti village, Kodaikanal taluk
near Kokkuparai Reserved Forest in Dindigul district in favour of Thiru.P.Mahalingam,
Kuppammalpatti, Kodaikanal Taluk, Dindigul District for a period of 20 years under
section 2 (1) of Van (Sanrakshan Eevam Samvardhan) Adhiniyam, 1980. The above
subject proposal is for diversion of forest land to patta owner and the non forest land
of 0.106 ha is identified in lieu of diversion of forest land.

2. In this connection, I am therefore directed to request you to explore whether
the patta owner can use some other path without diversion of the forest land and send
your report to Government immediately.
