Sub:- Proposal for diversion of 22.258 ha of balance forest land including 8.583 ha of safety zone as per Sabik settlement record as on 25.10.1980 in respect of Tailangi-A Chromite mines in village Talangi & Ostapal in Sukinda Tahasil of Jajpur District of M/s IDCOL.



On scrutiny of the above proposal submitted vide your memo under reference, the following discrepancies / deficiencies have been noticed.

1. As per online application 25.942 ha of non-forest land is involved in the proposal, but in check list Sl.No.8, it has been mentioned that no non-forest is proposed for diversion which needs revised as per the proforma.
2. As per the CA scheme enclosed in the Proposal, the non-forest land has been identified in village Madhupurgarh under Dharmasala Tahasil of Jajpur District, but in check list Sl.No.12,17 & 18, undertaking has been furnished for village Abhayapur under Darpan Tahasil of Jajpur District.
3. Land suitability certificate has been furnished for raising compensatory afforestation in respect of village- Abhayapur instead of village- Madhupurgarh.
4. The cost benefit analysis furnished at page-80 to 83 of the DP has not been signed by the DFO.
5. In part-II col. No. 10(i) regarding details of compensatory afforestation, it has been mentioned that non-forest land of 14 ha has been identified in village-Abhayapur which needs <sup>to be</sup> revised.
6. In the CA Scheme enclosed in the DP, it is seen at page-304 that 18 months old seedlings will be raised for CA but in the cost norm 6 months old seedlings has been calculated. In the mean-time the cost norm has been revised by the PCCF, Odisha and communicated to you vide Memo No.18547 dated 02.11.2021 which may be referred to. Further the wage rate has also been revised from Rs.311/- to Rs. 315/- which should be taken in to account. Hence the CA Scheme should be revised accordingly.

In view of the above, the Diversion Proposal received in your memo under reference is returned herewith in **five sets** for re-submission duly complying the observation as stated above to this office at the earliest.
