

8B/UP/06/76/2018/FC: Proposal for diversion of Forest land(31.58 ha) for four – laning of Naraini tokalinjar road from CH-35.000 Km to CH-60.825 Km. and from 0.00 to 1.500 Km on Kalinjar to Baghelbari road in Banda District of Uttar Pradesh.

The details of the proposals are as under:

- 1. The proposal has been signed and recommended by the all concerned authorities in the part I, II, III, IV & V. No specific comments have been made in Part II, III, IV and V regarding the proposal. The project is recommended in the interest of public importance.
- 2. As per Site inspection report and part-II of the proposal filled by the concerned DCF having territorial jurisdiction on proposed forest patches- violation of Forests (Conservation) Act-1980 has not been reported (Site inspection report at page no. 130).
- 3. As per part II of the proposal the proposed forest patch is not part of National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant Reserve, Wildlife Migration Corridor etc.
- 4. As per part II of the proposal; the proposed forest patches are not located in the area having protected archaeological / heritage site / defence establishment or any other important monument and no any rare/endangered/unique species of flora and fauna found in the area.
- 5. The requirement of forest land has been provided on page no.38 Justification of minimum area involved has been provided of the proposal.

- 7. The certificate of District Magistrate under Forests (Rights) Act 2006 is placed with the proposal on page no. 50 of proposal.
- 8. As per GIS-DSS analysis, proposed forest land for diversion and CA land have passed the GIS-DSS analysis (on page no.2-1/C).
- 9. The total outlay of the proposal is Rs 14230.04 Lakhs.
- 10. The details of employment generation through the proposal are temporary employment is 90000 man days permanent 5 person.
- 11. The cost benefit analysis is placed with the proposal on page no. 117-120 of proposal.

In view of the shortcomings observed in the proposal an EDS was issued on 17/10/2018 on following issues-

- a. Undertaking for disposal of Muck has been furnished by the user agency but Muckdisposal scheme has not been submitted.
- b. Land suitability certificates for CA land is not in Prescribed format.
- c. Copy of approval for construction of 'Road over bridge' in Protected Forest between chainage 41.350 to 42Km should be submitted.
- d. Undertaking of the user agency to bear the cost of affected plantation raised during 2014-15 is not attached.
- e. The Geo referenced Map of proposed Forest Land to be diverted does not provide detailed information of the land.
- f. Enumeration list of trees indicates that most of the trees are above 60 cm girth class. A site inspection report by Conservator of Forest/ Senior Officers may be carried out to suggest ways to minimize felling of trees.
- g. FRA certificate submitted does not certain the name of the signing officers.

The Reply of the State Government has been submitted vide letter no. 900/11-C-FP/UP/Road/25036/2017 dated 26.10.2018 of Nodal officer, Uttar Pradesh as follows-(a) Geo referenced Map having required information has been submitted.(b) Site inspection report by Conservator of Forests has been submitted.(c) FRA Certificate has been verified by authorized officers.(d) Undertaking to bear the cost of affected plantation by widening has been attached.(e) Revised land suitability certificate by DFO has been attached.(f) It has been stated that there will be no generation of waste material and hence no scheme for muck disposal is required.

The matter is placed before REC for consideration.

Decision of Regional Empowered Committee: -The Proposal was approved with standard terms & conditions, with this specific condition regarding submitting muck disposal plan duly endorsed by the State government within one month since the date of approval.
