

Sir,

I am directed to refer to the State Government's letter No. 5190510/FR.10/2023-2 dated 05/09/2024 on the above subject. In this regard, it is informed that as per the report of DFO, Kancheepuram, the road was not in existence as per topo sheet 66/D of 1976, whereas the User Agency claims that the road was established prior to 1985. Also, it is mentioned that there is no RoW was allowed in the Reserve Forest notifications where the diversion is sought. In view of the above, it is requested that the State Government may either submit evidences that the road was established prior to 1980 or to clarify as to why the proposal cannot be treated as a case of violation.
