Sir,

I am directed to refer to the State Government's letter no. 5445142/FR.10/2023-2 dated 19/08/2024 on the above subject. In this regard, it is requested that clarification /information on the following may be furnished for further processing of the proposal:-

- (i) As per the proposal, only a small portion of the road is proposed for upgradation /widening. The proposal needs to be considered in its entirety.

- (ii) It is reported that Right of Way (RoW) is available for 12 feet wide to a length of 686 m and present road is having width of 5.50 m with shoulder width of 1.0 m on either side. It may be clarified whether the RoW is included in the proposal or not. Also, a copy of the notification for existing RoW may be provided.
- (iii) Even though violation is reported, it is not clear whether violation of Tamil Nadu Forest Act, 1882 or Van (Samrakshan Evam Samvardhan) Adhiniyam, 1980 or both has taken place. The nature of violation, extent of violation, details of person /officials responsible for violation and action taken against violators may be provided.
