With reference to the subject and letter cited above, I am to inform you that the additional information submitted by State Government vide letter dated 04.12.2019 has been examined and it is observed that the proposed C.A site over 1.45 ha against the diversion of 0.7254 ha falls under Moderately Dense Forest, and another C.A site of 7.0 ha proposed against the diversion of 3.7158 ha, consists of 4.0 ha Moderately Dense Forest, 2.0 ha Open Forest and 1.0 ha Non-Forest, as per DSS software.

In view of the above, the State Govt is to find an alternate compensatory afforestation site as the proposed compensatory afforestation site is not found to be acceptable as per the report under DSS software. The State Govt is requested to submit the details of alternate compensatory afforestation site along with soft copy KML/Shape file to this office at the earliest for taking further necessary action.
